- I. The name of the Company is **SHREE PUSHKAR CHEMICALS* & *FERTILISERS LIMITED*.
- II. The Registered Office of the company will be situated in the state of Maharashtra.
- III. The objects for which the company is established are:

(A) THE MAIN OBJECTS OF THE COMPANY TO BE PURSUED BY THE COMPANY ON ITS INCORPORATION ARE:

1. *To carry on the business of manufacture, imports, exports, distributors, dealers, agents, wholesalers, retailers, jobwork and to deal in all types of petro products such as resin, synthetic organic, unorganic, dyes, pigments, colours, resin used in various process for manufacture of different types of materials viz. marbles, paint, dyestuff, pigments, inorganic, organic chemicals, agro chemical products, fertilizers and insecticides, pesticides, chemical, manure including nitrogenous, phosphoric, potassium like urea, ammonium sulphate, ammonium nitro phosphate and other nitrogen allied chemicals, super phosphate, single, double, triple and allied phosphoric manures, potassium manures and granulated manures, different compositions and of different proportions, diammonium phosphate, muriatic of potash, dolomite gypsum, organic manure, leather chloride, crystals, sodium nitrate, fertilizers, mixtures of calcium nitrate and ammonium nitrate and mixture of calcium nitrate and magnesium nitrate and also in all types of liquid and fertilizers andto manufacture of chemicals, medicines, manures, distillers, dye makers, metallurgists and electrical and mechanical manufacturing and consulting engineering, chemical acids, alkalies, petro chemicals, chemical compounds and chemicals of all kinds like solid, liquid and gaseous, drugs, medicines, pharmaceuticals, antibiotics, tannins, tannin extracts, essences, solvents, plastics of all types, dyestuffs, intermediates, textile auxiliaries, dyes, paints, varnishes, other organic dyestuff, chemicals, disinfectants, insecticides, fungicides, deodorants, bio chemicals, pharmaceuticals, sizing, bleaching, photographical and other preparation and articles and to produce and manufacture seeds, processed, seeds, concentrate for cattle or poultry feed and to manufacture various inorganic and organic compounds by all possible methods now prevalent or as they may be devised in future.

B. THE OBJECTS INCIDENTAL OR ANCILLARY TO THE ATTAINMENT OF THE MAIN OBJECTS :

- 2. To enter into trade or other combination of agreements with any other person; firm or Companies for similar business of the Company.
- 3. To enter into contracts, agreements and/or any type of collaboration tieups either alone or along with others for acquiring for own use plant and machineries, components, raw materials and other incidental and allied equipments.
- 4. To register trade names, brand names, marks and also to permit their uses to such persons, firms. Companies or corporations which adhere to such terms and conditions as laid down by the Company by making such rules and regulations as are necessary from time to time in that regard.
- 5. To enter into any arrangements with any Government or authorities, municipal, local or otherwise or any person, institution or Company in India or abroad that may seem conducive to the objects of the Company or any of them and to obtain from such Government authority, person institution or Company, rights, all sort of assistance privileges, charters, contracts, licenses and concessions which the Company may think it desirable and to carry out exercise end comply therewith.
- 6. To acquire and secure membership, seat or privilege either in name of the Company or its nominee or nominees in and of any association, exchange, market club or other institution in India or any part of the world for furtherance of any business, trade or industry.
- 7. To adopt such means of making known the products of the Company as may seem expedient and in particular by advertisement in the press by circular, by purchase and exhibition or works of art of interest, by publication of books and periodicals and by granting prizes, rewards and donations.

- 9. To apply or join in applying to any parliament, Government, Local Improvement Trust or other authority or body, Municipal, Local or otherwise in Dominion of India, Native States, Colonies or foreign countries for and to obtain or in any way assist in obtaining any Act of

Parliament, Laws, decrees, concessions, orders, rights or privileges or advantages that may seam conducive to the objects of this Company or for enabling this Company constitution to oppose any proceeding or applications union may seem calculated directly or indirectly or prejudice the interests of this Company to be legalised, registered or in-corporated if necessary in accordance with the laws of any country, state or place in which it may propose to carry on operations to establish and maintain any agencies of the Company and to open and keep a colonial or a foreign register of this Company in any foreign country, native state, colony or dependency and to allocate any number of these or any other shares in this Company to such register or registers.

- 10. To pay out of the funds of the Company all expenses of and incidental to the formation, registration, advertisements and establishment of this Company and the issue and subscription of the share or loan capital including brokerage and/or commission for obtaining applications for all placing or guaranteeing the placing of shares or any debentures, debenture-stock and other securities of this Company and also all expenses attending the issue of any circular or notice and the printing, stamping circulating of proxies and forms to be filled up by the members of the Company.
- 11. To effect all such insurances in relation to the carrying on of the Company's business and any risks incidental thereto as may seem expedient and if thought fit, to join or become a member of any mutual insurance Company or to carry a part or the whole of such insurance risk in connection with the Company's business.
- 12. To improve, manage, develop, grant rights or privileges in respect of, or otherwise deal with all or any part of the property and rights of the Company.
- 13. To draw, make, accept, endorse, discount, execute and issue promissory notes, bills of exchange warrants, debentures and other negotiable or transferable instruments.
- 14. To undertake and execute any contracts for works involving the supply or use of labour equipment and appliances and to carry out any ancillary or other works comprised in such contracts, concerning the main objects.

To amalgamate or enter into partnership or into any arrangement for sharing profits, union of interest, co-operation, joint ventures, reciprocal concessions, limiting competition or otherwise, with any person firm or Company carrying on or engaged in or about to carry on or be engaged in, any business or trans-actions which this Company is authorised to carry on or lend money to guarantee the contracts of or otherwise assist or subsidise any such person, firm or Company and to take or otherwise acquire, share and securities of any such Company, and to sell, hold, reissue with or without guarantee or otherwise deal with the same and to give to any person firm or Company special rights and privileges in connection with control over this Company and in particular the right to nominate one or more Directors of the Company.

To remunerate, whether by fixed sum or commission or participation in profits or partly in one way and partly in another the Officers, Employees and Directors of the Company or any parties for services rendered to be rendered or for acquisition of fixed and current assets or loans or rights or conduct of the business or activities or any other valuable consideration, by cash payment or by allotment of the shares, debentures or other securities of the Company credited as paid-up in full or in part or in kind or otherwise.

32. To make pecuniary grants by way of donations, bonus, subscription, allowance, provident fund, gratuity, guarantee or otherwise to or for the benefit of persons, who are or have been employed by the Company or otherwise and widows, orphans and dependants of any such persons and to or in aid of Association or Funds for the benefit or any of these objects and to hospital and for other charitable or benevolent objects or public institutions.

- 33. To employ or otherwise appoint technical experts, engineers, mechanics, foremen and skilled and unskilled labour for any of the purpose of the business of the Company.
- 34. To provide for the welfare of shareholders Ex-Shareholders, Directors, Officers, Employees and Ex-Directors, Ex-Officers and Ex-Employees of the Company and the wives, widows and families of the dependants or connections of such persons by building or contri-buting to the building of houses, dwellings or chawls or by grants of money, pensions, allowances, bonus or other payments, or by creating and from time, to time subscribing or contributing to provident gratuity, pension or other associations, institutions, funds, or trusts and by providing or by subscribing or contri-buting towards places of instructions and recreation, hospitals and dispensaries, medical and other attendants and other assistance as the Company shall think fit and to subscribe or contribute or otherwise to assist or to guarantee money to charitable, benevolent, religious, scientific national or other claim to support or aid by the Company either by reason of locality of operation of public and general utility or otherwise.
- 35. - 50. To make provision for entertainment of persons having or likely to have dealings with the Company or who are or have bean in the employment of the Company of their dependents.
- 51. To acquire by concession, grant, purchase, barter, lease, license or otherwise, either absolutely or conditionally and either solely or jointly with others, any houses, lands, farms, water right, way leaves and other works, privileges, rights and hereditaments and other movable and immovable property of any description, in India or elsewhere.
- 52. To let out or hire all or any of the property or personnel of any Company for such consideration as may be deemed fit.
- 53. To create any depreciation fund, reserve fund sinking fund, insurance fund, provident fund or any other special fund whether for depreciation or for repairing, replacing, improving, extending or maintaining any of the property of the Company for any other purpose conducive to the interest of the Company.
- 54. To distribute as bonus shares amongst the members or to place to reserve or otherwise to apply as the Company may, from time to time think fit, any moneys received by way of premium on shares or debentures issued at a premium by the Company and any money, received in respect of forfeited shares and money arising from the sale by the Company of forfeited shares.
- 55. To refer or agree to refer any claims, demands, disputes, or any other question by or against the Company or in which the Company is interested or concerned and whether between the Company and the member and members or his or their representatives or between the Company and third party to arbitration in India or at any place outside India and to observe and perform and to do all acts, deeds, matters and things to carry out or enforce the awards.
- 56. To institute, conduct, defend or compound any legal proceedings by or against the Company or its officers or otherwise concerning the affairs of the Company and pay, satisfy, or compromise any claim made against the Company or any of its officers notwithstanding that the claim may not be valid at law.
- 57. To act as trustees, executors, administrators, attorneys, nomineesand agents and to undertake and execute trusts of all kinds and(subject to compliance with any statutory condition) to exercise allthe powers of custodians, trustees and trust corporations.

- 58. To distribute among the members in specie any property, of the Company or any proceeds of sale or disposal of any property of the Company subject to the provisions of the Companies Act, 1956 in the event of winding up of the Company.
- 59. To generate, receive, produce, transmit, distribute, buy, sell and otherwise deal into Electric Power, Waste Heat Recovery based Power, Thermal Power, Hydraulic Power, Atomic Power, Wind Power, Solar Power, Renewable Energy, Organic & Inorganic mode of power generation and in this to erect and deal in all types of Power Plants, Waste Heat Recovery based Power Plants, substations, wires, cables, boards, switches and all other electric materials along with regular services for repairing & maintenance of all types to all forms of users.'

C. OTHER OBJECTS:

- 60. To act as selling agents, sales organizers as well as consultants, agents and advisers in all the respective branches and in such capacity to give advices and information and render advice in parson, a firm, Company or body incorporate or authority or Govern-ment which may lead to or be conducive to the adoption by the constituents or principals or generally of :
 - i. Efficient methods of effecting sales and marketing goods.
 - ii. Economy in effecting sales and marketing goods.
 - iii. Rendering of all services whether incidental to the above or not.
- 61. To investigate on behalf of any company, corporation, body corporate, industries, firm, association or any parson and
 - a. Collect information and data and submit reports, feasibility of new projects and/or improvements to and or expansion or existing projects and
 - b. To diagnose operational difficulties and weakness and suggest remedial measures to improve and moderate existing units.

To prepare and submit overall and detailed plans for civil and industrial execution to any Company, corporation, body or prepare and submit overall and detailed pals for civil and industrial execution to any company, corporation, body corporate, industries, firm, associations or any person with regard to :

- a. New Projects and/or
- b. Improvements and/or expansion of the existing projects.
- 62. To carry on the business of shipping agents, clearing and forwarding agents, transport and commission agents, cartage, contractors and agents for cargo consignments by air, sea, rail roads or any other mode of transport, custom agents, stevedores, wharefingers, cargo superintendents, warehousemen and storekeepers.

- 63. To carry on the business of electrical engineers, service engineers and of manufacturers, sellers, buyers, importers, exporters, assemblers, repairers of and dealers in all types of lamps material making, lighting, lamps lamp making machinery, displays, display devices, display components, display systems, electric and electronic appliances, apparatus, instruments, machines, articles and/or all their components, materials, gases, accessories allied products or any of them or any combination, variation or improvement therein.
- 64. To buy and sell, exchange, import, export and otherwise deal in cotton, jute, deeds, grain, rice, wheat, tea, coffee, chinchona, rubber, gum, tobacco and other products of the soiled silk, wool fibres and other fibrous substances and products, thereof, oilcakes, paints, varnishes dyes, chemicals, metals, mineral, timber coal, sugar, matches, paper, glass, hardware, machinery, crockery, cutlery, porcelain, gems, jewellery, precious stones, ivory, gold silver, bullion, building materials, sanitary ware, groceries, spices, provisions, preparations and compounds, plastics, electrical, photographic, surgical and scientific instruments, apparatus and materials, hides and skins, hosiery, textiles, leather goods, live and dead stocks and all other goods, produce, materials, articles, products, substances and merchandise of any nature of kind whatsoever.
- To carry on the business of commission agents, indenting agents, selling 65. agents, buying agents or brokers for any person or organisation for any territory in India or outside India and work as manu-facturer's representatives.
- 66. To carry on the business of travel agents and tourist and contractors and to facilitate travailing and to procure and provide for tourists and travellers booking by air, rail, sea, road and other means of travel and to handle inland and foreign tours.
- 67. To run manage or let on hire taxi clubs, deluxe, coaches, lorries, cars, trucks, station wagons, airships, rail, motors, vessels, ferries, boats and all other vehicles of whatsoever kind propelled by electricity, gas, gasoline, compressed air, steam, manual power, mechanised power, oil, crude oil, automatic or other energy, or by whatsoever means and from one place to another (whether within India or otherwise) for the purpose of carrying, conveying, transporting things and generally to do the business of common carriers.
- 68. To search for, win, get, raise, imports crush, mani-pulate and prepare for the market and deal in ores, coals, clay and minerals.
- 69. To carry on the business of Investment Company and to invest in and acquire and hold and otherwise deal in shares, stocks, debentures, debenture stock, bonds, obligations and securities issued or guaranteed by any Company constituted or carrying on business in India or elsewhere and debentures, debenture stock, bond, obligations and securities, issued or guaranteed by any Government, state, dominion, sovereign ruler, commissioner, public body or authority supreme, municipal, local or otherwise whether in India or elsewhere.
- 70. To carry on business of operating agencies of various manufacturers in India and abroad and marketing of products of such Companies.
- 71. To carry on and work and business of cultivators, buyers and sellers of every kind of vegetable, mineral or other produce of the soil, including

cotton, sugar cane, nuts, perfume producing vegetation, to prepare manufacture and render marketable any such produce and to sell, dispose of and deal in any such produce either in its prepared manufactured or ran state and either by wholesale or retail.

- 72. To carry on the business of makers and manufacturers of artificial manures and fertilisers of every description in all its branches.
- 73. To carry on the business of money lenders, financiers, guaranteed brokers.
- 74. To carry on business as merchants, traders, commission agents, buying and selling agents, brokers, adatias, buyers and sellers, importers, exporters, dealers, collectors, or in any other capacity in India or elsewhere and to import, export, buy, sell, barter exchange, pledge, mortgage, advance upon or otherwise trade and deal in goods, produce, articles and merchandise or any kind whatsoever.
- 75. To carry on the business of production, distribution or exhibition of films and motion pictures including the running, of theatres, cinemas, studios, cinemato-graphic shows, exhibitions and planetariums and of cameras, studio cine cameras, sound systems, cine film, video films, film processing equipments and projects.
- 76. To carry on the business of manufacturers of or dealers in trucks, tractors, automobiles, two-wheelers, auto-rickshaws, mopeds, bicycles, cranes, earth-moving machines and equipment, internal combustion engines, boilers, locomotives and compressors and to manufacture and/or deal in automobile parts, spare parts and components or machineries and to act as agents for manufacturers of various parts and components.
- 77. To carry on the business of makers of scientific, industrial and surgical instruments, mechanical, engineers and manufacturers of agricultural implements and other machinery, steel castings, tool makers, iron founders, brass founders, metal workers, boiler makers, machinists, iron and steel converters, smiths and to buy, sell, manufacture, repair, convert, let on hire and deal in machinery implements and hardware of all kinds.
- 78. To carry on any business relating to the mining and smelting of and dealing in minerals, coal, ores, precious stones, metals and other substances and the production and working of ferrous, non-ferrous and ultra pure metals and allays in all their forms and the production, manufacture and preparation of any other material.
- 79. To carry on the business of electrical engineers, electricians, contractors, manufacturers, importers, repairers, assemblers, hirers, suppliers, of and dealers in electric, electronic and other appliances, electric motors, fans, furnaces, household appliances, batteries, cables, wires, dry cell, accumulators. conductors, dynamos, armatures, magnets, insulators, magnators, transformers converters, switch boards, distribution boards, electronic equipment including radars, calculators, mini-computers, computers business machines, radios, television sets, tape recorders, gramophone, records, tapes and cartridges, telecommunication equipment and their components and accessories including transistors, resistors, condensers and coils and generally electrical and electronic plants and appliances and suppliers of every description.

80. To carry on the business of manufacturing, assembling, buying, selling, reselling, exchanging, altering, imparting, exporting, hiring, plying, operating, letting on hire, distributing of or dealing in ships, boats, barges, launches, sub-marines and other under-water vessels, aero engines, air ships, sea planes, flying boats and carriers of every descripting whether propelled or moved or assisted by means of petrol, spirit, electricity, steam, oil, vapour, gas, petroleum, mechanical, animal or any other motive power and all the components parts, accessories, equipments and apparatus for any use in connection therewith.

- 81. To carry on the business of manufactures of and dealers in glass products including sheet and plate glass optical glass, glass wool, laboratory ware, glass tubes, glass rods, glass shells, crystal glass, quartz glass, alumina, soda glass, lead glass, glass beds, glass to metal seals borosilicate glass, silica glass, fused silica glass and any other type of glass.
- 82. To carry on the business of manufacturers of or dealers in textiles including man-made fibers, cotton, silk, jute, woolen and synthetics.
- 83. To carry on the business of manufacturers of or dealers in industrial machinery of all types including bearings, speed reduction units, pumps, machine tools, agricultural and earth moving machinery including road rollers, bull dozers, dumpers, scrapers, traders, shovels, drag lines and light engineering goods and their components.
- 84. To carry on the business as manufacturers, dealers, stockists, measuring tools, machine tools, garage tools, nuts, nails, rivets, hinges, hooks and all other harduare items of all types and description.
- 85. To carry on the business as manufacturers, dealers, stockists, importers and exporters of forgings, castings, stampings, of all metals, machinery parts, moulds, press tools, jigs, fixtures, injections and compression moulding steal products and spare parts and spares of all kinds of machinery.
- 86. To manufacture, stock, import, export, sell and service all the types of wires including dumet wires, molybdenum wires, rods, sheets and boats, kovar wire, special alloy wire, resistance wire, nicrome wires, tungsten, gold, silver, brass, copper, aluminum, nickel and moly wires, lead-in-wires and fuse wires and of annealing and enameling of wires.
- 87. To carry on the business of manufacturers, dealers, stockists, importers and exporters of wearable and un-wearable fabrics, high density polythene, poly propylene, woven sacks, tarpaulins of various qualities and types.
- 88. To carry on the business of manufacturers, dealers, stockists, importers and exporters of wearable and un-wearable fabrics, high density polythene, poly propylene, woven, sacks, tarpaulins, of various qualities and types.
- 89. To carry on the business of dairy farming, dairy products and allied products and of manufacturing of and dealing in dairy equipment, dairy chemicals, dairy testing material alcohol, butyrometers and stoppers, centrifuges, milk cans, bottle filling machines, pouch packing machine and dairy accessories, cattle feed and feeding and flattening preparation of every description.

90. To carry on the business of timber and lumber merchants, lumber yard and saw mill proprietors and to buy, sell, prepare for the market, import, export and deal in articles and furniture of all kinds in the manufacture of

which timber or wood is used and to carry on the business of logging and lumbering purchasing, acquiring and leasing timber berths and so far as may be deemed expedient, the business of general merchants.

- 91. To carry on the business of manufacturers of or dealers in soaps, cosmetics, perfumes and toilet requisites.
- 92. To carry on the business of manufacturers of or-dealers in pulp and paper of all kinds and articles made from paper of pulp and material used in the manufacture of treatment of paper, including card-board, mill boards, stray boards, corrugated boards and newsprint.
- 93. To carry on the business of manufacture of and dealer buyers, sellers, retailers, wholesalers, importers, exporters, stores, of pharmaceuticals, pharmaceuticals products, drugs medicines, patent medicines, lotions, formulations, intermediates, pills, injections, intravenous and intramuscular, pharmaceuticals, plasma, solvents, compounds, herbs.
- 94. To carry on the business of purchase and sale of petroleum and petroleum products and petrochemicals and to act as dealers and distributors for petroleum Companies, to run service stations for the repairs end servicing of automobiles and to manufacture or deal in fuel oils, cutting oils, grease.
- 95. To carry on the business of manufacturers of and dealers in all types of celluloid, bakelite, thermo-setting and thermo plastics, rubber and plastic goods, particularly industrial rolls, rollers sheets, beltings and consumer goods such as tyres, tubes and other allied products, toys, medical and surgical goods and all other kinds of products.
- 96. To carry on business as goldsmiths, silversmiths, jewellers, gem merchants, electro-platers, importers exporters of bullion, precious stones, jewellery, watches, clocks, gold or silver plates, cups, shields, electroplated cutlery dressing bags, brasses, articles of virtue, objects of art and such other articles and goods and to manufacture and establish factories for manufacturing goods, for the above business.
- 97. To carry on the business as manufacturers, of and dealers in all types of valves, pumps and engineering products of all types of machinery and machinery parts, spare parts, instrumentation and systems and import and export such item and/or to deal and trade in them.
- 98. To carry on the business as manufacturers of or dealers in typewriters, cleaners, sewing and printing machines, air-conditioning, equipment, air-conditioners, refrigerators, cooler and ice-cream manufacturing machinery and to maintain air-conditioning godowns for cold storage of goods.
- 99. To carry on the business of steam and general laundry and to wash, clean, purify, scour, bleach, wring, dry, iron, colour, dye, disinfect, renovate and prepare for use, all articles of wearing apparel, household domestic and other, cotton, silk and woolen fabrics, repair, let on hire, alter, improve, treat and deal in all apparatus, machines, materials and articles of all

- 100. To acquire or set up and run hospitals, clinics, nursing homes, maternity and family planning units or pathological laboratories and optician shops, dispensaries, child welfare centers, diagnostic centers and crèches.
- 101. To carry on the business as manufacturers of or dealers in, or as stockists importers and exporters of packing materials, cartoons, containers, boxes and cases made of paper, boards, foils, wood, glass, plastic, pulp, cellulose, polythene, films, rubber, metals, metal foils, gelatins tin, flexible, treated, laminated or other materials.
- 102. To carry on the business of carpet making and all kinds of imitation leathers, plastics and rubber end also water proof goods and articles manufactured there from including dress, preserves, dress linings, boot linings, umbrellas, parasols, flags, tents, picture frames, artificial flowers and also floor cloths and table cloth.
- 104. To carry on the manufactures and sale of patent medicines and preparations and to carry on the business of manufacturers, buyers end sellers of and dealers in all kinds of medicines and medical preparations and drugs whatsoever and obtain patents for them.
- 105. To carry on the business as manufacturers of and dealers in or as stockists, importers and exporters of audio meters, hearing aids, surgical instruments, including attery forceps, operating surgical micro-scopes binocular microscopes, laboratory and research microscopes, stere-microscope, metallurgical microscopes, electron-pstagographic equipment, including photo electric cell apparatus for microlargyngoal survey, cautrisation apparatus and apparatus and apparatus for facial nerve stimulation.
- 106. To carry on the business as manufacturers of and dealers in or as stockists, importers and exporters of operating tables, operating lights head mirrors, beds, wheel chairs, trolleys, cupboard incubation tubes, anesthetic equipments and oxygen cylinder.
- 107. To carry on all or any of the business and professions of providing services of all types including techni-cal, administrative, industrial, management, taxation, financial, marketing engineering, data processing, construction, Company promotion and providing services of technicians, scientists, artists, administrations attorneys, nominees and agents and of working as professional consultants on technical, financial, administrative, management, production, business systems taxation, employment, investment, marketing, banking and economic problems and matters and/or to carry on the business of preparing, printing and supplying of books, magazines, pamphlets, journals and as agents in connection therewith.
- 108. To procure or develop and supply patents, inventions, models, designs,

scientific or industrial formula or processes, to procure or develop and supply technical know-how for the manufacture or processing of goods, materials, or the installation or erection of machinery or plant, for such manufacture or processing, or in the working of mines, oil wells, or other

sources of mineral deposit or in research for or discovery or testing of mineral deposits, or in carrying out any operation relating to agriculture, animal husbandry, dairy or poultry farming, forestry or fishing or rendering services in connection with the provision of such technical know-how.

- 109. To acquire or set up and run schools, colleges, train-ing and professional institutions, music and dance centers.
- 110. To carry on the business of an investment Company dealing in Shares, Debentures and finance.
- 111. To manufacture or deal in bricks, tiles, sanitary ware, bathroom fittings, fixtures, flushing cisterns, commodes, wash basins, pipes and tubes of plastic, clay or any other material, earth ware, pottery articles, china and terracotta and ceramic wares of all kinds and pre-fabricated pre-stressed concrete beams, poles, slabs and building materials and requisites of all kinds.
- 112. To carry on the business of garage proprietors, or livestock stable keepers, job masters, dairymen, importers and brokers of food, live and dead stock and foreign produce of all descriptions, perfumes, chemists, laundries, reading, writing and newspaper rooms, recreation sports, entertainment and instrument of all kinds, tobacco and cigar merchants, travel agents, bank mukadams, for railways shipping and airways and road, transport corporations, contractors, caterers, in railway, airlines and steamship Companies, underwriters and insurers of ship crafts, goods and other property, theatrical and opera box office owners, ship proprietors, conducing safe deposit vaults, general agents, ice merchants and to carry on the business of swimming pools, bakery and confectionery.
- 113. To carry on the business as bakers and manufacturers of and dealers in bread, flour, rava, maida, biscuits and farinacious, compounds and materials of every description, sugar, gur, khandasari, sugar candy, chocolates, toffees and other allied products.
- 114. To carry on the business as bakers, distillers and manufacturers of and merchants and dealers in vinegar, acetic acid, glucose, wines, spirit, beers, porter, malt, hops, grain, meal, yeast, aerated water, carbonic acid gas, mustard pickles, sauces, condiments of all kinds cocoa, coffee, preserves and all or any other commodity and things which may be conveniently used or manufactured in conjunction with any of the above or any similar business or manufacture.
- 115. To carry on the business of stationers, painters, lithographers, printers, stereotypers, electrotypers, photographic printers, photo lithographers, engravers, diesinkers, envelope manufacturers, book binders, account books manufacturers, machine rulers numerical printers, paper maker, paper bag and account book makers, box makers, cardboard manufacturers, type founders, photographers, manufacturers of and dealers in playing cards, show cards, complimentary and fancy cards and valentines, dealers in parchment, dealers in stamps, agents for payment of stamp and other duties, advertising agents, designers, draught men, book sellers, publishers, paper manufacturers and dealers in

materials used in manufacture or paper, or dealers in or manufacturers of any articles or things of a character similar or analogous to the forgoing or any of them or connected therewith.

- 116. To carry on the business of manufacturers of and dealers in hides, chappals, boots, shoes, clogs all kinds of footwear and leather and plastic goods, lasts, laces, buckles, leggings and accessories and fittings.
- 117. To carry on the business of tobacconists in all its branches and sell, make up and manufacture tobacco, cigar, cigarettes, snuff and other articles usually sold by tobacconists.
- 118. To carry on the business of establishing, running, operating, hiring, letting on hire, all types of plants, machinery and equipment solvent extraction, expeller, hydrogenation, refining of edible oils, dal and rice mills, gour gum industry, gums and starches of all kinds, whether natural or synthetic.
- 119. To carry on all or any or the business of undertaking or arranging for the writing printing and publication of books of any nature, magazines journal or pamphlets or posters on subjects relating to trade, commerce, industry, agriculture, medicine, banking, accounting, auditing, insurance, telecommunication, electronics, electricals investment, taxation, finance, economics, law and other subjects.
- 120. To carry on the business of manufacturers of and dealers in all types of electronic items, instruments, apparatus and appliances, including in particular oscilloscopes, microprocessors, video tape recorder, video cameras, timber counters, pattern generators, signal generators, stabilized power supplies, infrared scanners and cameras, sold cells, solar heaters, digital meters, digital clocks, reflect meters, temperature probes, pulse generators, printed circuits boards, ultrasonic generators and flaw detectors, peripherals ferrite cores, connectors, thyristor devices, stereo systems, intercoms, wireless transmitters and receivers plasma welders and plasma ray generators.
- 121. To act as a Trustee, professional trustee, debenture trustee and to accept the confidence or trust with or without remuneration.
- 122. To carry on business as wood and timber merchants and manufactures of and dealers in wood, wood blocks for flooring and other, purposes, box windows, doors, woodheels and soles, wool letters, wood pulp, wood, plywood, masts, spare, derricks, sleepers, tool handles, paneling, wood work, furniture, brick and wood worker's materials and suppliers of equipment of all description.
- 123. To carry on business of advisers on problems relating to the admintration and organisation of industry and business and the selection and for training of personnel for industry and business and personnel consultants and to advise upon the means and methods for extending, developing and improving business or industries and systems or processes relating to the production, storage distribution, marketing and sale of goods and/ or relating to the rendering of services and provide data processing techniques for systems and programming work.
- 124. To establish and carry on in India or in any part of the world schools at or by means of which students may obtain education and instruction by post or otherwise and particularly in or with regard to book keeping

commerce, shorthand typewriting and other engineering and training in data processing techniques for systems and programming work and

professions of accountancy and all other subjects whatsoever that may be included in a commercial, technical, scientific, classical or academic education or may be conducive to knowledge of skill in any trade pursuit or calling.

- 125. To provide, a school or schools, lecture class or examination room or rooms, office or offices, board lodging and attendance and all other necessities and convenience for or to students, teachers, lecturers, clerk, employees-arid officers instructed or employed temporarily or otherwise by the Company and to, afford them facilities for study, research, cultivation, teaching and performance of the tasks and duties allotted to them respectively.
- 126. To own, purchase, charter, hire or otherwise acquire, sell, exchange, let or otherwise deal with operate, trade in ships, boats and vessels, sea crafts, trawlers, aircrafts and transports and conveyances propelled or worked or capable or being propelled or worked by steam electricity, petrol, oil, gas or other motive power or power producing substance with all equipment with furniture, build steam and ships and vessels and to employ the same in the carriage or conveyance, by land, sea or air in or between and place or places or port or ports or on any seas, river, canals or elsewhere of passengers, mails, live stock, produce and merchandise and food article and good things between such ports and places in any part of the world and to establish maintain and work, lines of steam and other ships, air services and lines of aerial communication and other transports and conveyance between any ports, countries or places.
- 127. To carry on business of builders, repairers, breakers and refitters of ships, trawlers, platforms, rigs, vessels, tugs, barges, lighters and aircrafts and other transport and conveyances and manufacturers and/ or repairers of engines, boilers, tickles, machinery and any part required for ships, vessels, or aircraft and any apparatus for use in connection therewith.
- 128. To construct and establish docks, berths, workshops, buildings, machinery and other conveniences and to carry on the business of proprietors of docks, wharves, jetties, piers, warehouses and stores and to ship, tug, lighter and barge owners shipwrights, dredgers, ship freight and insurance brokers.
- 129. To own, equip and fit up all plant, machinery, equip-ment, appliances and accessories, yard, factories or works for building, repairing, equipping stationing steamers, ships, vessels, launches, boats, trawlers, aircrafts and all other transports and conveyances.

AND IT IS HEREBY DECLARED THAT:

- a. The objects incidental or ancillary to the attainment of the main objects of the Company aforesaid shall also be incidental or ancillary to the attainment of other objects herein mentioned.
- b. The word "COMPANY" (Save when used with reference to this Company) in this Memorandum of Association shall be deemed to include any person or partnership or other body or association of persons, whether incorporated or not and wherever domiciled.

- c. Nothing in this Memorandum of Association shall authorise the Company to do any business or transaction or to take any action prohibited by the Companies Act, 1956, Banking Regulation Act, 1949, Insurance Act, 1938 and any other Act, Law, Rules, Circulars and notification for the time being in force.

Commission

- Calls on uniform 38. Whenever any calls for further share capital are made on shares, such calls shall be made on uniform basis on all shares falling under the same class. For the purposes of this Article shares of the same nominal value of which different amounts have been paid up shall not be deemed to fall under the same class.
- Directors may extend time. 39. The Board may, from time to time, at its discretion, extend the time fixed for the payment of any call and may extend such time as to all or any of the members who on account of the residence at a distance or other cause, which the Board may deem fairly entitled to such extension, but no member shall be entitled to such extension save as a matter of grace and favour.
- Calls to carry 40. If any Member fails to pay any call due from him on the day appointed for payment thereof, or any such extension thereof as aforesaid, he shall be liable to pay interest on the same from the day appointed for the payment thereof to the time of actual payment at such rate as shall from time to time be fixed by the Board not exceeding 21% per annum but nothing in this Article shall render it obligatory for the Board to demand or recover any interest from any such member.
- Sums deemed to be calls. 41. If by the terms of issue of any share or otherwise any amount is made payable at any fixed time or by installments at fixed time (whether on account of the amount of the share or by way of premium) every such amount or installment shall be payable as if it were a call duly made by the Directors and of which due notice has been given and all the provisions herein contained in respect of calls shall apply to such amount or installment accordingly.
- Proof on trial of 42. On the trial or hearing of any action or suit brought by the Company suit for money against any Member or his representatives for the recovery of any money due on shares. claimed to be due to the Company in respect of his shares, if shall be sufficient to prove that the name of the Member in respect of whose shares the money is sought to be recovered, appears entered on the Register of Members as the holder, at or subsequent to the date at which the money is sought to be recovered is alleged to have become due on the share in respect of which such money is sought to be recovered in the Minute Books: and that notice of such call was duly given to the Member or his representatives used in pursuance of these Articles: and that it shall not be necessary to prove the appointment of the Directors who made such call, nor that a guorum of Directors was present at the Board at which any call was made was duly convened or constituted nor any other matters whatsoever, but the proof of the matters aforesaid shall be conclusive evidence of the debt.
- Judgment, decree, partial payment motto proceed for forfeiture.
 43. Neither a judgment nor a decree in favour of the Company for calls or other moneys due in respect of any shares nor any part payment or satisfaction thereunder nor the receipt by the Company of a portion of any money which shall from time to time be due from any Member of the Company in respect of his shares, either by way of principal or interest, nor any indulgence granted by the Company in respect of the payment of any such money, shall preclude the Company from thereafter proceeding to enforce forfeiture of such shares as hereinafter provided.

- 44. (a) The Board may, if it thinks fit, receive from any Member willing to advance the same, all or any part of the amounts of his respective shares beyond the sums, actually called up and upon the moneys so paid in advance, or upon so much thereof, from time to time, and at any time thereafter as exceeds the amount of the calls then made upon and due in respect of the shares on account of which such advances are made the Board may pay or allow interest, at such rate as the member paying the sum in advance and the Board agree upon. The Board may agree to repay at any time any amount so advanced or may at any time repay the same upon giving to the Member three months' notice in writing: provided that moneys paid in advance of calls on shares may carry interest but shall not confer a right to dividend or to participate in profits.
 - (b) No Member paying any such sum in advance shall be entitled to voting rights in respect of the moneys so paid by him until the same would but for such payment become presently payable. The provisions of this Article shall mutatis mutandis apply to calls on debentures issued by the Company.

LIEN

- 45. The Company shall have a first and paramount lien upon all the shares/ debentures (other than fully paid-up shares/debentures) registered in the name of each member (whether solely or jointly with others) and upon the proceeds of sale thereof for all moneys (whether presently payable or not) called or payable at a fixed time in respect of such shares/ debentures and no equitable interest in any share shall be created except upon the footing and condition that this Article will have full effect. And such lien shall extend to all dividends and bonuses from time to time declared in respect of such shares/debentures. Unless otherwise agreed the registration of a transfer of shares/debentures shall operate as a waiver of the Company's lien if any, on such shares/debentures. The Directors may at any time declare any shares/debentures wholly or in part to be exempt from the provisions of this clause.
- 46. For the purpose of enforcing such lien the Directors may sell the shares subject thereto in such manner as they shall think fit, but no sale shall be made until such period as aforesaid shall have arrived and until notice in writing of the intention to sell shall have been served on such member or the person (if any) entitled by transmission to the shares and default shall have been made by him in payment, fulfillment of discharge of such debts, liabilities or engagements for seven days after such notice. To give effect to any such sale the Board may authorise some person to transfer the shares sold to the purchaser thereof and purchaser shall be registered as the holder of the shares comprised in any such transfer. Upon any such sale as the Certificates in respect of the shares sold shall stand cancelled and become null and void and of no effect, and the Directors shall be entitled to issue a new Certificate or Certificates in lieu thereof to the purchaser or purchasers concerned.
- 47. The net proceeds of any such sale shall be received by the Company A and applied in or towards payment of such part of the amount in respect of which the lien exists as is presently payable and the residue, if any, shall (subject to lien for sums not presently payable as existed upon the shares before the sale) be paid to the person entitled to the shares at the date of the sale.

FORFEITURE AND SURRENDER OF SHARES

- If call or 48. installment not paid, notice may be given.
 - If any Member fails to pay the whole or any part of any call or installment or any moneys due in respect of any shares either by way of principal or interest on or before the day appointed for the payment of the same, the Directors may, at any time thereafter, during such time as the call or installment or any part thereof or other moneys as aforesaid remains unpaid or a judgment or decree in respect thereof remains unsatisfied in whole or in part, serve a notice on such Member or on the person (if any) entitled to the shares by transmission, requiring him to pay such call or installment of such part thereof or other moneys as remain unpaid together with any interest that may have accrued and all reasonable expenses (legal or otherwise) that may have been accrued by the Company by reason of such non-payment. Provided that no such shares shall be forfeited if any moneys shall remain unpaid in respect of any call or installment or any part thereof as aforesaid by reason of the delay occasioned in payment due to the necessity of complying with the provisions contained in the relevant exchange control laws or other applicable laws of India, for the time being in force.
- Terms of notice. 49. The notice shall name a day (not being less than fourteen days from the date of notice) and a place or places on and at which such call or installment and such interest thereon as the Directors shall determine from the day on which such call or installment ought to have been paid and expenses as aforesaid are to be paid.

The notice shall also state that, in the event of the non-payment at or before the time and at the place or places appointed, the shares in respect of which the call was made or installment is payable will be liable to be forfeited.

- On default of payment, shares to be forfeited. 50. If the requirements of any such notice as aforesaid shall not be complied with, every or any share in respect of which such notice has been given, may at any time thereafter but before payment of all calls or installments, interest and expenses, due in respect thereof, be forfeited by resolution of the Board to that effect. Such forfeiture shall include all dividends declared or any other moneys payable in respect of the forfeited share and not actually paid before the forfeiture.
- Notice of forfeiture to a Member 51. When any shares have been forfeited, notice of the forfeiture shall be given to the member in whose name it stood immediately prior to the forfeiture, and an entry of the forfeiture, with the date thereof shall forthwith be made in the Register of Members.

Forfeited shares 52. to be property of the Company and may be sold etc. Any shares so forfeited, shall be deemed to be the property of the Company and may be sold, re-allotted, or otherwise disposed of, either to the original holder thereof or to any other person, upon such terms and in such manner as the Board in their absolute discretion shall think fit.

Members still 53. Any Member whose shares have been forfeited shall notwithstanding liable to pay the forfeiture, be liable to pay and shall forthwith pay to the Company, money owing at on demand all calls, installments, interest and expenses owing upon or time of forfeiture in respect of such shares at the time of the forfeiture, together with and interest. interest thereon from the time of the forfeiture until payment, at such rate as the Board may determine and the Board may enforce the payment of the whole or a portion thereof as if it were a new call made at the date Sections 83 and of the forfeiture, but shall not be under any obligation to do so. 108 of the Act not to apply

- Effect of 54. The forfeiture shares shall involve extinction at the time of the forfeiture. forfeiture, of all interest in all claims and demand against the Company, in respect of the share and all other rights incidental to the share, except only such of those rights as by these Articles are expressly saved.
- 55. A declaration in writing that the declarant is a Director or Secretary of Forfeiture. the Company and that shares in the Company have been duly forfeited in accordance with these articles on a date stated in the declaration, shall be conclusive evidence of the facts therein stated as against all persons claiming to be entitled to the shares.
- 56. The Company may receive the consideration, if any, given for the share on any sale, re-allotment or other disposition thereof and the person to whom such share is sold, re-allotted or disposed of may be registered as the holder of the share and he shall not be bound to see to the application of the consideration: if any, nor shall his title to the share be affected by any irregularly or invalidity in the proceedings in reference to the forfeiture, sale, re-allotment or other disposal of the shares.
- 57. Upon any sale, re-allotment or other disposal under the provisions of the preceding Article, the certificate or certificates originally issued in respect of the relative shares shall (unless the same shall on demand by the Company have been previously surrendered to it by shares. the defaulting member) stand cancelled and become null and void and of no effect, and the Directors shall be entitled to issue a duplicate certificate or certificates in respect of the said shares to the person or persons entitled thereto.
- 58. In the meantime and until any share so forfeited shall be sold, reallotted, or otherwise dealt with as aforesaid, the forfeiture thereof may, at the discretion and by a resolution of the Directors, be remitted as a matter of grace and favour, and not as was owing thereon to the Company at the time of forfeiture being declared with interest for the same unto the time of the actual payment thereof if the Directors shall think fit to receive the same, or on any other terms which the Director may deem reasonable.
- 59. Upon any sale after forfeiture or for enforcing a lien in purported exercise of the powers hereinbefore given, the Board may appoint someperson to execute an instrument of transfer of the Shares sold and cause the purchaser's name to be entered in the Register of Members in respect of the Shares sold, and the purchasers shall not be bound to see to the regularity of the proceedings or to the application of the purchase money, and after his name has been entered in the Register of Members in respect of such Shares, the validity of the sale shall not be impeached by any person and the remedy of any person aggrieved by the sale shall be in damages only and against the Company exclusively.
- 60. The Directors may, subject to the provisions of the Act, accept a Surrender of shares. surrender of any share from or by any Member desirous of surrendering on such terms the Directors may think fit.

- (a) The instrument of transfer of any share in or debenture of the Company shall be executed by or on behalf of both the transferor and transferee.
- (b) The transferor shall be deemed to remain a holder of the share or debenture until the name of the transferee is entered in the Register of Members or Register of Debenture holders in respect thereof.
- Transfer Form. 62. The instrument of transfer of any share or debenture shall be in writing and all the provisions of Section 56 and statutory modification thereof including other applicable provisions of the Act shall be duly complied with in respect of all transfers of shares or debenture and registration thereof.

The instrument of transfer shall be in a common form approved by the Exchange;

- Transfer not to 63. The Company shall not register a transfer in the Company other than be registered the transfer between persons both of whose names are entered as except on holders of beneficial interest in the records of a depository, unless a production of proper instrument of transfer duly stamped and executed by or on behalf instrument of transfer. of the transferor and by or on behalf of the transferee and specifying the name, address and occupation if any, of the transferee, has been delivered to the Company along with the certificate relating to the shares or if no such share certificate is in existence along with the letter of allotment of the shares: Provided that where, on an application in writing made to the Company by the transferee and bearing the stamp, required for an instrument of transfer, it is proved to the satisfaction of the Board of Directors that the instrument of transfer signed by or on behalf of the transferor and by or on behalf of the transferee has been lost, the Company may register the transfer on such terms as to indemnity as the Board may think fit, provided further that nothing in this Article shall prejudice any power of the Company to register as shareholder any person to whom the right to any shares in the Company has been transmitted by operation of law.
- Directors may 64. refuse to register transfer. Subject to the provisions of Section 58 of the Act and Section 22A of the Securities Contracts (Regulation) Act, 1956, the Directors may, decline to register—
 - (a) any transfer of shares on which the company has a lien.
- Notice of refusal 65. to be given to transferor and transferee. If the Company refuses to register the transfer of any share or transmission of any right therein, the Company shall within one month from the date on which the instrument of transfer or intimation of transmission was lodged with the Company, send notice of refusal to the transferee and transferor or to the person giving intimation of the transmission, as the case may be, and there upon the provisions of Section 56 of the Act or any statutory modification thereof for the time being in force shall apply.

- 66. No fee shall be charged for registration of transfer, transmission, Probate, No fee on transfer. Succession Certificate and letter of administration, Certificate of Death or Marriage, Power of Attorney or similar other document with the Company.
- 67. The Board of Directors shall have power on giving not less than seven days pervious notice in accordance with section 91 and rules made thereunder close the Register of Members and/or the Register of debentures holders and/or other security holders at such time or times and for such period or periods, not exceeding thirty days at a time, and not exceeding in the aggregate forty five days at a time, and not exceeding in the aggregate forty five days in each year as it may seem expedient to the Board.
- 68. The instrument of transfer shall after registration be retained by the Custody of Company and shall remain in its custody. All instruments of transfer which the Directors may decline to register shall on demand be returned to the persons depositing the same. The Directors may cause to be destroyed all the transfer deeds with the Company after such period as they may determine.
- 69. Where an application of transfer relates to partly paid shares, the transfer transfer of shall not be registered unless the Company gives notice of the application partly paid to the transferee and the transferee makes no objection to the transfer shares. within two weeks from the receipt of the notice.
- 70. For this purpose the notice to the transferee shall be deemed to have been duly given if it is dispatched by prepaid registered post/speed post/ courier to the transferee at the address given in the instrument of transfer and shall be deemed to have been duly delivered at the time at which it would have been delivered in the ordinary course of post.
- 71. (a) On the death of a Member, the survivor or survivors, where the legal Member was a joint holder, and his his nominee or nominees or legal representatives where he was a sole holder, shall be the only person recognized by the Company as having any title to his interest in the shares.
 - Before recognising any executor or administrator or legal (b) representative, the Board may require him to obtain a Grant of Probate or Letters Administration or other legal representation as the case may be, from some competent court in India.

Provided nevertheless that in any case where the Board in its absolute discretion thinks fit, it shall be lawful for the Board to dispense with the production of Probate or letter of Administration or such other legal representation upon such terms as to indemnity or otherwise, as the Board in its absolute discretion, may consider adequate

(c) Nothing in clause (a) above shall release the estate of the deceased joint holder from any liability in respect of any share which had been jointly held by him with other persons.

However, provisions of this Article are subject to Sections 72of the Companies Act.

Notice of application when to be given 73. Where, in case of partly paid Shares, an application for registration is made by the transferor, the Company shall give notice of the application to the transferee in accordance with the provisions of Section 56 of the Act.

Registration of 74. Subject to the provisions of the Act and these Articles, any person persons entitled becoming entitled to any share in consequence of the death, lunacy, to share bankruptcy, insolvency of any member or by any lawful means other otherwise than than by a transfer in accordance with these presents, may, with the by transfer. (Transmission consent of the Directors (which they shall not be under any obligation to clause). give) upon producing such evidence that he sustains the character in respect of which he proposes to act under this Article or of this title as the Director shall require either be registered as member in respect of such shares or elect to have some person nominated by him and approved by the Directors registered as Member in respect of such shares; provided nevertheless that if such person shall elect to have his nominee registered he shall testify his election by executing in favour of his nominee an instrument of transfer in accordance so he shall not be freed from any liability in respect of such shares. This clause is hereinafter referred to as the 'Transmission Clause'.

Refusal to register nominee. 75. The Company shall incur no liability or responsibility whatsoever in consequence of its registering or giving effect to any transfer of shares made, or purporting to be made by any apparent legal owner thereof (as shown or appearing in the Register or Members) to the prejudice of persons having or claiming any equitable right, title or interest to or in the same shares notwithstanding that the Company may have had notice of such equitable right, title or interest or notice prohibiting registration of such transfer, and may have entered such notice or referred thereto in any book of the Company and the Company shall not be bound or require to regard or attend or give effect to any notice which may be given to them of any equitable right, title or interest, or be under any liability whatsoever for refusing or neglecting so to do though it may have been entered or referred to in some book of the Company but the Company shall nevertheless be at liberty to regard and attend to any such notice and give effect thereto, if the Directors shall so think fit.

- 78. In the case of any share registered in any register maintained outside Form of India the instrument of transfer shall be in a form recognized by the law of the place where the register is maintained but subject thereto shall be as near to the form prescribed in Form no. SH-4 hereof as circumstances permit.
- 79. No transfer shall be made to any minor, insolvent or person of unsound insolvent etc. mind.

NOMINATION

- 80. i) Notwithstanding anything contained in the articles, every holder Nomination of securities of the Company may, at any time, nominate a person in whom his/her securities shall vest in the event of his/her death and the provisions of Section 72 of the Companies Act, 2013shall apply in respect of such nomination.
 - ii) No person shall be recognized by the Company as a nominee unless an intimation of the appointment of the said person as nominee has been given to the Company during the lifetime of the holder(s) of the securities of the Company in the manner specified under Section 72of the Companies Act, 2013 read with Rule 19 of the Companies (Share Capital and Debentures) Rules, 2014
 - iii) The Company shall not be in any way responsible for transferring the securities consequent upon such nomination.
 - iv) If the holder(s) of the securities survive(s) nominee, then the nomination made by the holder(s) shall be of no effect and shall automatically stand revoked.
- 81. A nominee, upon production of such evidence as may be required by the Board and subject as hereinafter provided, elect, either-
 - (i) to be registered himself as holder of the security, as the case may be; or
 - (ii) to make such transfer of the security, as the case may be, as the deceased security holder, could have made;
 - (iii) if the nominee elects to be registered as holder of the security, himself, as the case may be, he shall deliver or send to the Company, a notice in writing signed by him stating that he so elects and such notice shall be accompanied with the death certificate of the deceased security holder as the case may be;

- Joint Holders 83. Where two or more persons are registered as the holders of any share they shall be deemed to hold the same as joint Shareholders with benefits of survivorship subject to the following and other provisions contained in these Articles.
- Joint and several 84. (a) The Joint holders of any share shall be liable severally as well as jointly for and in respect of all calls and other payments which ought to be made in respect of such share.

SHARE WARRANTS

Power to issue share warrants 85. The Company may issue warrants subject to and in accordance with provisions of the Act and accordingly the Board may in its discretion with respect to any Share which is fully paid upon application in writing

- 86. (a) The bearer of a share warrant may at any time deposit the warrant Deposit of at the Office of the Company, and so long as the warrant remains so deposited, the depositor shall have the same right of signing a requisition for call in a meeting of the Company, and of attending and voting and exercising the other privileges of a Member at any meeting held after the expiry of two clear days from the time of deposit, as if his name were inserted in the Register of Members as the holder of the Share included in the deposit warrant.
 - (b) Not more than one person shall be recognized as depositor of the Share warrant.
 - (c) The Company shall, on two day's written notice, return the deposited share warrant to the depositor.
- 87. (a) Subject as herein otherwise expressly provided, no person, being Privile a bearer of a share warrant, shall sign a requisition for calling a meeting of the Company or attend or vote or exercise any other privileges of a Member at a meeting of the Company, or be entitled to receive any notice from the Company.
 - (b) The bearer of a share warrant shall be entitled in all other respects to the same privileges and advantages as if he were named in the Register of Members as the holder of the Share included in the warrant, and he shall be a Member of the Company.
- 88. The Board may, from time to time, make bye-laws as to terms on which Issue of new (if it shall think fit), a new share warrant or coupon may be issued by way of renewal in case of defacement, loss or destruction.

CONVERSION OF SHARES INTO STOCK

- 89. The Company may, by ordinary resolution in General Meeting.
 - a) convert any fully paid-up shares into stock; and
 - b) re-convert any stock into fully paid-up shares of any denomination.
- 90. The holders of stock may transfer the same or any part thereof in the Tr same manner as and subject to the same regulation under which the shares from which the stock arose might before the conversion have been transferred, or as near thereto as circumstances admit, provided that, the Board may, from time to time, fix the minimum amount of stock transferable so however that such minimum shall not exceed the nominal amount of the shares from which the stock arose.

- Regulations. 92. Such of the regulations of the Company (other than those relating to share warrants), as are applicable to paid up share shall apply to stock and the words "share" and "shareholders" in those regulations shall include "stock" and "stockholders" respectively.

BORROWING POWERS

- Subject to the provisions of the Act and these Articles, the Board may, Power to borrow, 93. from time to time at its discretion, by a resolution passed at a meeting of the Board generally raise or borrow money by way of deposits, loans, overdrafts, cash credit or by issue of bonds, debentures or debenturestock (perpetual or otherwise) or in any other manner, or from any person, firm, company, co-operative society, any body corporate, bank, institution, whether incorporated in India or abroad, Government or any authority or any other body for the purpose of the Company and may secure the payment of any sums of money so received, raised or borrowed; provided that the total amount borrowed by the Company (apart from temporary loans obtained from the Company's Bankers in the ordinary course of business) shall not without the consent of the Company in General Meeting exceed the aggregate of the paid up capital of the Company and its free reserves that is to say reserves not set apart for any specified purpose.
- Issue of discount 94. etc. or with special privileges. Subject to the provisions of the Act and these Articles, any bonds, debentures, debenture-stock or any other securities may be issued at a discount, premium or otherwise and with any special privileges and conditions as to redemption, surrender, allotment of shares, appointment of Directors or otherwise; provided that debentures with the right to allotment of or conversion into shares shall not be issued except with the sanction of the Company in General Meeting.
- Securing 95. The payment and/or repayment of moneys borrowed or raised as payment or aforesaid or any moneys owing otherwise or debts due from the Company repayment of may be secured in such manner and upon such terms and conditions in Moneys all respects as the Board may think fit, and in particular by mortgage, borrowed. charter, lien or any other security upon all or any of the assets or property (both present and future) or the undertaking of the Company including its uncalled capital for the time being, or by a guarantee by any Director, Government or third party, and the bonds, debentures and debenture stocks and other securities may be made assignable, free from equities between the Company and the person to whom the same may be issued and also by a similar mortgage, charge or lien to secure and guarantee, the performance by the Company or any other person or company of any obligation undertaken by the Company or any person or Company as the case may be.

- 96. Any bonds, debentures, debenture-stock or their securities issued or to be issued by the Company shall be under the control of the Board who may issue them upon such terms and conditions, and in such manner and for such consideration as they shall consider to be for the benefit of the Company.
- 97. If any uncalled capital of the Company is included in or charged by any mortgage or other security the Directors shall subject to the provisions of the Act and these Articles make calls on the members in respect of such uncalled capital in trust for the person in whose favour such mortgage or security is executed.
- 98. Subject to the provisions of the Act and these Articles if the Directors or be given. any of them or any other person shall incur or be about to incur any liability whether as principal or surely for the payment of any sum primarily due from the Company, the Directors may execute or cause to be executed any mortgage, charge or security over or affecting the whole or any part of the assets of the Company by way of indemnity to secure the Directors or person so becoming liable as aforesaid from any loss in respect of such liability.

MEETINGS OF MEMBERS

- 99. All the General Meetings of the Company other than Annual General Meetings shall be called Extra-ordinary General Meetings.
- 100. The Directors may, whenever they think fit, convene an Extra-(a) Ordinary General Meeting and they shall on requisition of requisition of Members made in compliance with Section 100 of the Act, forthwith proceed to convene Extra-Ordinary General Meeting of the members
 - (b) If at any time there are not within India sufficient Directors capable of acting to form a guorum, or if the number of Directors be reduced in number to less than the minimum number of Directors prescribed by these Articles and the continuing Directors fail or neglect to increase the number of Directors to that number or to convene a General Meeting, any Director or any two or more Members of the Company holding not less than one-tenth of the total paid up share capital of the Company may call for an Extra-Ordinary General Meeting in the same manner as nearly as possible as that in which meeting may be called by the Directors.
- 101. No General Meeting, Annual or Extraordinary shall be competent to enter upon, discuss or transfer any business which has not been mentioned in the notice or notices upon which it was convened.
- 102. The Chairman (if any) of the Board of Directors shall be entitled to take the chair at every General Meeting, whether Annual or Extraordinary. If there is no such Chairman of the Board of Directors, or if at any meeting he is not present within fifteen minutes of the time appointed for holding such meeting or if he is unable or unwilling to take the chair, then the Members present shall elect another Director as Chairman, and if no Director be present or if all the Directors present decline to take the chair then the Members present shall elect one of the members to be the Chairman of the meeting.

- 103. No business, except the election of a Chairman, shall be discussed at any General Meeting whilst the Chair is vacant.

 - b) No business shall be transacted at any adjourned meeting other than the business left unfinished at the meeting from which the adjournment took place.
 - c) When a meeting is adjourned for thirty days or more, notice of the adjourned meeting shall be given as in the case of an original meeting.
 - d) Save as aforesaid, and as provided in section 103 of the Act, it shall not be necessary to give any notice of an adjournment or of the business to be transacted at an adjourned meeting.
- Chairman's 105. In the case of an equality of votes the Chairman shall both on a show of hands, on a poll (if any) and e-voting, have casting vote in addition to the vote or votes to which he may be entitled as a Member.

In what case poll 106. taken without adjournment. Any poll duly demanded on the election of Chairman of the meeting or any question of adjournment shall be taken at the meeting forthwith.

Demand for poll 107. The demand for a poll except on the question of the election of the chairman and of an adjournment shall not prevent the continuance of a meeting for the transaction of any business other than the question on which the poll has been demanded.

VOTES OF MEMBERS

- Members in arrears not to vote. 108. No Member shall be entitled to vote either personally or by proxy at any General Meeting or Meeting of a class of shareholders either upon a show of hands, upon a poll or electronically, or be reckoned in a quorum in respect of any shares registered in his name on which any calls or other sums presently payable by him have not been paid or in regard to which the Company has exercised, any right or lien.
- Number of votes 109. Subject to the provision of these Articles and without prejudice to any each member special privileges, or restrictions as to voting for the time being attached entitled. to any class of shares for the time being forming part of the capital of the company, every Member, not disgualified by the last preceding Article shall be entitled to be present, and to speak and to vote at such meeting, and on a show of hands every member present in person shall have one vote and upon a poll the voting right of every Member present in person or by proxy shall be in proportion to his share of the paid-up equity share capital of the Company, Provided, however, if any preference shareholder is present at any meeting of the Company, save as provided in sub-section (2) of Section 47 of the Act, he shall have a right to vote only on resolution placed before the meeting which directly affect the rights attached to his preference shares.

- 110. On a poll taken at a meeting of the Company a member entitled to more than one vote or his proxy or other person entitled to vote for him, as the case may be, need not, if he votes, use all his votes or cast in the same way all the votes he uses.
- 111. A member of unsound mind, or in respect of whom an order has been made by any court having jurisdiction in lunacy, or a minor may vote, whether on a show of hands or on a poll, by his committee or other legal guardian, and any such committee or guardian may, on a poll, vote by proxy.
- 112. Notwithstanding anything contained in the provisions of the Companies Postal Ballot Act, 2013, and the Rules made there under, the Company may, and in the case of resolutions relating to such business as may be prescribed by such authorities from time to time, declare to be conducted only by postal ballot, shall, get any such business/ resolutions passed by means of postal ballot, instead of transacting the business in the General Meeting of the Company.
- 113. A member may exercise his vote at a meeting by electronic means in E-Voting accordance with section 108 and shall vote only once.
- 114. (a) In the case of joint holders, the vote of the senior who tenders a members. vote, whether in person or by proxy, shall be accepted to the exclusion of the votes of the other joint holders. If more than one of the said persons remain present than the senior shall alone be entitled to speak and to vote in respect of such shares, but the other or others of the joint holders shall be entitled to be present at the meeting. Several executors or administrators of a deceased Member in whose name share stands shall for the purpose of these Articles be deemed joints holders thereof.
 - (b) For this purpose, seniority shall be determined by the order in which the names stand in the register of members.
- Votes may be given either personally or by attorney or by proxy or in 115. case of a company, by a representative duly Authorised as mentioned in Articles
- 116. A body corporate (whether a company within the meaning of the Act or not) may, if it is member or creditor of the Company (including being a holder of debentures) authorise such person by resolution of its Board of Directors, as it thinks fit, in accordance with the provisions of Section 113 of the Act to act as its representative at any Meeting of the members or creditors of the Company or debentures holders of the Company. A person authorised by resolution as aforesaid shall be entitled to exercise the same rights and powers (including the right to vote by proxy) on behalf of the body corporate as if it were an individual member, creditor or holder of debentures of the Company.
- 117. (a) A member paying the whole or a part of the amount remaining unpaid on any share held by him although no part of that amount has been called up, shall not be entitled to any voting rights in respect of the moneys paid until the same would, but for this payment, become presently payable.

Any person entitled under Article 73 (transmission clause) to transfer any share may vote at any General Meeting in respect thereof in the same manner as if he were the registered holder of such shares, provided that at least forty-eight hours before the time of holding the meeting or adjourned meeting, as the case may be at which he proposes to vote he shall satisfy the Directors of his right to transfer such shares and give such indemnify (if any) as the Directors may require or the directors shall have previously admitted his right to vote at such meeting in respect thereof.
- No votes by proxy on show of hands. 119. No Member shall be entitled to vote on a show of hands unless such member is present personally or by attorney or is a body Corporate present by a representative duly Authorised under the provisions of the Act in which case such members, attorney or representative may vote on a show of hands as if he were a Member of the Company. In the case of a Body Corporate the production at the meeting of a copy of such resolution duly signed by a Director or Secretary of such Body Corporate and certified by him as being a true copy of the resolution shall be accepted by the Company as sufficient evidence of the authority of the appointment.
- Appointment of a Proxy. 120. The instrument appointing a proxy and the power-of-attorney or other authority, if any, under which it is signed or a notarised copy of that power or authority, shall be deposited at the registered office of the company not less than 48 hours before the time for holding the meeting or adjourned meeting at which the person named in the instrument proposes to vote, or, in the case of a poll, not less than 24 hours before the time appointed for the taking of the poll; and in default the instrument of proxy shall not be treated as valid.
- Form of proxy. 121. An instrument appointing a proxy shall be in the form as prescribed in the rules made under section 105.
- Validity of votes given by proxy notwithstanding death of a member. 122. A vote given in accordance with the terms of an instrument of proxy shall be valid notwithstanding the previous death or insanity of the Member, or revocation of the proxy or of any power of attorney which such proxy signed, or the transfer of the share in respect of which the vote is given, provided that no intimation in writing of the death or insanity, revocation or transfer shall have been received at the office before the meeting or adjourned meeting at which the proxy is used.
- Time for objections to votes. 123. No objection shall be raised to the qualification of any voter except at the meeting or adjourned meeting at which the vote objected to is given or tendered, and every vote not disallowed at such meeting shall be valid for all purposes.
- Chairperson of the Meeting to be the judge of validity of any vote. 124. Any such objection raised to the qualification of any voter in due time shall be referred to the Chairperson of the meeting, whose decision shall be final and conclusive.

DIRECTORS

- 125. Until otherwise determined by a General Meeting of the Company and subject to the provisions of Section 149 of the Act, the number of Directors (including Debenture and Alternate Directors) shall not be less than three and not more than fifteen. Provided that a company may appoint more than fifteen directors after passing a special resolution
- 126. A Director of the Company shall not be bound to hold any Qualification Qualification Shares in the Company.
- 127. (a) Subject to the provisions of the Companies Act, 2013and Nominee notwithstanding anything to the contrary contained in these Directors. Articles, the Board may appoint any person as a director nominated by any institution in pursuance of the provisions of any law for the time being in force or of any agreement
 - (b) The Nominee Director/s so appointed shall not be required to hold any qualification shares in the Company nor shall be liable to retire by rotation. The Board of Directors of the Company shall have no power to remove from office the Nominee Director/s so appointed. The said Nominee Director/s shall be entitled to the same rights and privileges including receiving of notices, copies of the minutes, sitting fees, etc. as any other Director of the Company is entitled.
 - (c) If the Nominee Director/s is an officer of any of the financial institution the sitting fees in relation to such nominee Directors shall accrue to such financial institution and the same accordingly be paid by the Company to them. The Financial Institution shall be entitled to depute observer to attend the meetings of the Board or any other Committee constituted by the Board.
 - (d) The Nominee Director/s shall, notwithstanding anything to the Contrary contained in these Articles, be at liberty to disclose any information obtained by him/them to the Financial Institution appointing him/them as such Director/s.
- 128. The Board may appoint an Alternate Director to act for a Director App (hereinafter called "The Original Director") during his absence for a period of not less than three months from India. An Alternate Director appointed under this Article shall not hold office for period longer than that permissible to the Original Director in whose place he has been appointed and shall vacate office if and when the Original Director returns to India. If the term of Office of the Original Director is determined before he so returns to India, any provision in the Act or in these Articles for the automatic re-appointment of retiring Director and not to the Alternate Director.
- 129. Subject to the provisions of the Act, the Board shall have power at any Addition. time and from time to time to appoint any other person to be an Additional Director. Any such Additional Director shall hold office only upto the date of the next Annual General Meeting.

- Directors power 130. Subject to the provisions of the Act, the Board shall have power at any to fill casual vacancies. Subject to the provisions of the Act, the Board shall have power at any time and from time to time to appoint a Director, if the office of any director appointed by the company in general meeting is vacated before his term of office expires in the normal course, who shall hold office only upto the date upto which the Director in whose place he is appointed would have held office if it had not been vacated by him.

Until otherwise determined by the Company in General Meeting, each Director other than the Managing/Whole-time Director (unless otherwise specifically provided for) shall be entitled to sitting fees not exceeding a sum prescribed in the Act (as may be amended from time to time) for attending meetings of the Board or Committees thereof.

Meetings of 133. (a) The Board of Directors may meet for the conduct of business, Directors. adjourn and otherwise regulate its meetings as it thinks fit. (b) A director may, and the manager or secretary on the requisition of a director shall, at any time, summon a meeting of the Board. The Directors may from time to time elect from among their Chairperson 134. (a) members a Chairperson of the Board and determine the period for which he is to hold office. If at any meeting of the Board, the Chairman is not present within five minutes after the time appointed for holding the same, the Directors present may choose one of the Directors then present to preside at the meeting. (b) Subject to Section 203 of the Act and rules made there under, one person can act as the Chairman as well as the Managing Director or Chief Executive Officer at the same time. Questions at 135. Questions arising at any meeting of the Board of Directors shall be Board meeting decided by a majority of votes and in the case of an equality of votes, how decided. the Chairman will have a second or casting vote. Continuing 136. The continuing directors may act notwithstanding any vacancy in the directors may act Board; but, if and so long as their number is reduced below the quorum notwithstanding fixed by the Act for a meeting of the Board, the continuing directors or any vacancy in the Board director may act for the purpose of increasing the number of directors to that fixed for the quorum, or of summoning a general meeting of the company, but for no other purpose. Directors may 137. Subject to the provisions of the Act, the Board may delegate any of their appoint powers to a Committee consisting of such member or members of its committee. body as it thinks fit, and it may from time to time revoke and discharge any such committee either wholly or in part and either as to person, or purposes, but every Committee so formed shall in the exercise of the

powers so delegated conform to any regulations that may from time to time be imposed on it by the Board. All acts done by any such Committee in conformity with such regulations and in fulfillment of the purposes of their appointment but not otherwise, shall have the like force and effect as if done by the Board.

- 138. The Meetings and proceedings of any such Committee of the Board consisting of two or more members shall be governed by the provisions herein contained for regulating the meetings and proceedings of the Directors so far as the same are applicable thereto and are not superseded by any regulations made by the Directors under the last preceding Article.
- 139. a) A committee may elect a Chairperson of its meetings.
 - b) If no such Chairperson is elected, or if at any meeting the Chairperson is not present within five minutes after the time appointed for holding the meeting, the members present may choose one of their members to be Chairperson of the meeting.
- 140. a) A committee may meet and adjourn as it thinks fit.
 - b) Questions arising at any meeting of a committee shall be determined by a majority of votes of the members present, and in case of an equality of votes, the Chairperson shall have a second or casting vote.
- 141. Subject to the provisions of the Act, all acts done by any meeting of the Board or by a Committee of the Board, or by any person acting as a Director shall notwithstanding that it shall afterwards be discovered that there was some defect in the appointment of such Director or persons acting as aforesaid, or that they or any of them were disqualified or had vacated office or that the appointment of any of them had been terminated by virtue of any provisions contained in the Act or in these Articles, be as valid as if every such person had been duly appointed, and was qualified to be a Director.

RETIREMENT AND ROTATION OF DIRECTORS

142. Subject to the provisions of Section 161 of the Act, if the office of any Director appointed by the Company in General Meeting vacated before his term of office will expire in the normal course, the resulting casual vacancy may in default of and subject to any regulation in the Articles of the Company be filled by the Board of Directors at the meeting of the Board and the Director so appointed shall hold office only up to the date up to which the Director in whose place he is appointed would have held office if had not been vacated as aforesaid.

POWERS OF THE BOARD

143. The business of the Company shall be managed by the Board who may exercise all such powers of the Company and do all such acts and things as may be necessary, unless otherwise restricted by the Act, or by any other law or by the Memorandum or by the Articles required to be exercised by the Company in General Meeting. However no regulation made by the Company in General Meeting shall invalidate any prior act of the Board which would have been valid if that regulation had not been made.

- Certain powers of the Board 144. Without prejudice to the general powers conferred by the Articles and so as not in any way to limit or restrict these powers, and without prejudice to the other powers conferred by these Articles, but subject to the restrictions contained in the Articles, it is hereby, declared that the Directors shall have the following powers, that is to say
 - (1) Subject to the provisions of the Act, to purchase or otherwise acquire any lands, buildings, machinery, premises, property, effects, assets, rights, creditors, royalties, business and goodwill of any person firm or company carrying on the business which this Company is authorised to carry on, in any part of India.
 - (2) Subject to the provisions of the Act to purchase, take on lease for any term or terms of years, or otherwise acquire any land or lands, with or without buildings and out-houses thereon, situate in any part of India, at such conditions as the Directors may think fit, and in any such purchase, lease or acquisition to accept such title as the Directors may believe, or may be advised to be reasonably satisfy.
 - (3) To erect and construct, on the said land or lands, buildings, houses, warehouses and sheds and to alter, extend and improve the same, to let or lease the property of the company, in part or in whole for such rent and subject to such conditions, as may be thought advisable; to sell such portions of the land or buildings of the Company as may not be required for the company; to mortgage the whole or any portion of the property of the company for the purposes of the Company; to sell all or any portion of the machinery or stores belonging to the Company.
 - (4) At their discretion and subject to the provisions of the Act, the Directors may pay property rights or privileges acquired by, or services rendered to the Company, either wholly or partially in cash or in shares, bonds, debentures or other securities of the Company, and any such share may be issued either as fully paid up or with such amount credited as paid up thereon as may be agreed upon; and any such bonds, debentures or other securities may be either specifically charged upon all or any part of the property of the Company and its uncalled capital or not so charged.
 - (5) To insure and keep insured against loss or damage by fire or otherwise for such period and to such extent as they may think proper all or any part of the buildings, machinery, goods, stores, produce and other moveable property of the Company either separately or co-jointly; also to insure all or any portion of the goods, produce, machinery and other articles imported or exported by the Company and to sell, assign, surrender or discontinue any policies of assurance effected in pursuance of this power.
 - (6) To open accounts with any Bank or Bankers and to pay money into and draw money from any such account from time to time as the Directors may think fit.

- (9) To appoint any person to accept and hold in trust, for the Company property belonging to the Company, or in which it is interested or for any other purposes and to execute and to do all such deeds and things as may be required in relation to any such trust, and to provide for the remuneration of such trustee or trustees.
- (10)To institute, conduct, defend, compound or abandon any legal proceeding by or against the Company or its Officer, or otherwise concerning the affairs and also to compound and allow time for payment or satisfaction of any debts, due, and of any claims or demands by or against the Company and to refer any difference to arbitration, either according to Indian or Foreign law and either in India or abroad and observe and perform or challenge any award thereon.
- (11) To act on behalf of the Company in all matters relating to bankruptcy insolvency.
- (12)To make and give receipts, release and give discharge for moneys payable to the Company and for the claims and demands of the Company.
- (13)Subject to the provisions of the Act, and these Articles to invest and deal with any moneys of the Company not immediately required for the purpose thereof, upon such authority (not being the shares of this Company) or without security and in such manner as they may think fit and from time to time to vary or realise such investments. Save as provided in Section 187 of the Act, all investments shall be made and held in the Company's own name.
- (14)To execute in the name and on behalf of the Company in favour of any Director or other person who may incur or be about to incur any personal liability whether as principal or as surety, for the benefit of the Company, such mortgage of the Company's property (present or future) as they think fit, and any such mortgage may contain a power of sale and other powers, provisions, covenants and agreements as shall be agreed upon;
- (15)To determine from time to time persons who shall be entitled to sign on Company's behalf, bills, notes, receipts, acceptances, endorsements, cheques, dividend warrants, releases, contracts and documents and to give the necessary authority for such purpose, whether by way of a resolution of the Board or by way of a power of attorney or otherwise.

- (17) To give, award or allow any bonus, pension, gratuity or compensation to any employee of the Company, or his widow, children, dependents, that may appear just or proper, whether such employee, his widow, children or dependents have or have not a legal claim on the Company.
- (18)To set aside out of the profits of the Company such sums as they may think proper for depreciation or the depreciation funds or to insurance fund or to an export fund, or to a Reserve Fund, or Sinking Fund or any special fund to meet contingencies or repay debentures or debenture-stock or for equalizing dividends or for repairing, improving, extending and maintaining any of the properties of the Company and for such other purposes (including the purpose referred to in the preceding clause) as the Board may, in the absolute discretion think conducive to the interests of the Company, and subject to Section 179 of the Act, to invest the several sums so set aside or so much thereof as may be required to be invested, upon such investments (other than shares of this Company) as they may think fit and from time to time deal with and vary such investments and dispose of and apply and extend all or any part thereof for the benefit of the Company notwithstanding the matters to which the Board apply or upon which the capital moneys of the Company might rightly be applied or expended and divide the reserve fund into such special funds as the Board may think fit; with full powers to transfer the whole or any portion of a reserve fund or division of a reserve fund to another fund and with the full power to employ the assets constituting all or any of the above funds, including the depredation fund, in the business of the company or in the purchase or repayment of debentures or debenture-stocks and without being bound to keep the same separate from the other assets and without being bound to pay interest on the same with the power to the Board at their discretion to pay or allow to the credit of such funds, interest at such rate as the Board may think proper.

(19) To appoint, and at their discretion remove or suspend such general manager, managers, secretaries, assistants, supervisors, scientists, technicians, engineers, consultants, legal, medical or economic advisers, research workers, labourers, clerks, agents and servants, for permanent, temporary or special services as they may from time to time think fit, and to determine their powers and duties and to fix their salaries or emoluments or remuneration and to require security in such instances and for such amounts they may think fit and also from time to time to provide for the management and transaction of the affairs of the Company in any specified locality in India or elsewhere in such manner as they think fit and the provisions contained in the next following clauses shall be without prejudice to the general powers conferred by this clause.

To appoint and remove officers and other employees.

- (20)To appoint At any time and from time to time by power of attorney under the Attorneys. seal of the Company, to appoint any person or persons to be the Attorney or attorneys of the Company, for such purposes and with such powers, authorities and discretions (not exceeding those vested in or exercisable by the Board under these presents and excluding the power to make calls and excluding also except in their limits authorised by the Board the power to make loans and borrow moneys) and for such period and subject to such conditions as the Board may from time to time think fit, and such appointments may (if the Board think fit) be made in favour of the members or any of the members of any local Board established as aforesaid or in favour of any Company, or the shareholders, directors, nominees or manager of any Company or firm or otherwise in favour of any fluctuating body of persons whether nominated directly or indirectly by the Board and any such powers of attorney may contain such powers for the protection or convenience for dealing with such Attorneys as the Board may think fit, and may contain powers enabling any such delegated Attorneys as aforesaid to sub-delegate all or any of the powers, authorities and discretion for the time being vested in them.
- (21) Subject to Sections 188 of the Act, for or in relation to any of the contracts. matters aforesaid or otherwise for the purpose of the Company to enter into all such negotiations and contracts and rescind and vary all such contracts, and execute and do all such acts, deeds and things in the name and on behalf of the Company as they may consider expedient.
- (22)From time to time to make, vary and repeal rules for the regulations of the business of the Company its Officers and employees.
- (23)To effect To effect, make and enter into on behalf of the Company all transactions, agreements and other contracts within the scope of the business of the Company.
- (24) To apply for, promote and obtain any act, charter, privilege, concession, license, authorization, if any, Government, State or municipality, provisional order or license of any authority for enabling the Company to carry any of this objects into effect, or for extending and any of the powers of the Company or for effecting any modification of the Company's constitution, or for any other purpose, which may seem expedient and to oppose any proceedings or applications which may seem calculated, directly or indirectly to prejudice the Company's interests.
- (25) To pay and charge to the capital account of the Company any To pay commission or interest lawfully payable there out under the provisions of Sections 40 of the Act and of the provisions contained in these presents.
 - commissions or interest.

(26) To redeem preference shares. To redeem preference shares.

To enter into

To make rules.

contracts etc.

To apply & obtain concessions licenses etc. To assist charitable or benevolent institutions.

- (27) To subscribe, incur expenditure or otherwise to assist or to guarantee money to charitable, benevolent, religious, scientific, national or any other institutions or subjects which shall have any moral or other claim to support or aid by the Company, either by reason of locality or operation or of public and general utility or otherwise.
- (28) To pay the cost, charges and expenses preliminary and incidental to the promotion, formation, establishment and registration of the Company.
- (29) To pay and charge to the capital account of the Company any commission or interest lawfully payable thereon under the provisions of Sections 40 of the Act.
- (30) To provide for the welfare of Directors or ex-Directors or employees or ex-employees of the Company and their wives, widows and families or the dependents or connections of such persons, by building or contributing to the building of houses, dwelling or chawls, or by grants of moneys, pension, gratuities, allowances, bonus or other payments, or by creating and from time to time subscribing or contributing, to provide other associations, institutions, funds or trusts and by providing or subscribing or contributing towards place of instruction and recreation, hospitals and dispensaries, medical and other attendance and other assistance as the Board shall think fit and subject to the provision of Section 181 of the Act, to subscribe or contribute or otherwise to assist or to guarantee money to charitable, benevolent, religious, scientific, national or other institutions or object which shall have any moral or other claim to support or aid by the Company, either by reason of locality of operation, or of the public and general utility or otherwise.
- (31) To purchase or otherwise acquire or obtain license for the use of and to sell, exchange or grant license for the use of any trade mark, patent, invention or technical know-how.
- (32) To sell from time to time any Articles, materials, machinery, plants, stores and other Articles and thing belonging to the Company as the Board may think proper and to manufacture, prepare and sell waste and by-products.
- (33) From time to time to extend the business and undertaking of the Company by adding, altering or enlarging all or any of the buildings, factories, workshops, premises, plant and machinery, for the time being the property of or in the possession of the Company, or by erecting new or additional buildings, and to expend such sum of money for the purpose aforesaid or any of them as they be thought necessary or expedient.
- (34) To undertake on behalf of the Company any payment of rents and the performance of the covenants, conditions and agreements contained in or reserved by any lease that may be granted or assigned to or otherwise acquired by the Company and to purchase the reversion or reversions, and otherwise to acquire on free hold sample of all or any of the lands of the Company for the time being held under lease or for an estate less than freehold estate.

- (35) To improve, manage, develop, exchange, lease, sell, resell and re-purchase, dispose off, deal or otherwise turn to account, any property (movable or immovable) or any rights or privileges belonging to or at the disposal of the Company or in which the Company is interested.
- (36) To let, sell or otherwise dispose of subject to the provisions of Section 180 of the Act and of the other Articles any property of the Company, either absolutely or conditionally and in such manner and upon such terms and conditions in all respects as it thinks fit and to accept payment in satisfaction for the same in cash or otherwise as it thinks fit.
- (37) Generally subject to the provisions of the Act and these Articles, to delegate the powers/authorities and discretions vested in the Directors to any person(s), firm, company or fluctuating body of persons as aforesaid.
- (38) To comply with the requirements of any local law which in their opinion it shall in the interest of the Company be necessary or expedient to comply with.

MANAGING AND WHOLE-TIME DIRECTORS

- 145. Subject to the provisions of the Act and of these Articles, the (a) Powers to appoint Directors may from time to time in Board Meetings appoint one Managing/ or more of their body to be a Managing Director or Managing Wholetime Directors or whole-time Director or whole-time Directors of the Directors. Company for such term not exceeding five years at a time as they may think fit to manage the affairs and business of the Company, and may from time to time (subject to the provisions of any contract between him or them and the Company) remove or dismiss him or them from office and appoint another or others in his or their place or places.
 - (b) The Managing Director or Managing Directors or whole-time Director or whole-time Directors so appointed shall be liable to retire by rotation. A Managing Director or Whole-time Director who is appointed as Director immediately on the retirement by rotation shall continue to hold his office as Managing Director or Whole-time Director and such re-appointment as such Director shall not be deemed to constitute a break in his appointment as Managing Director or Whole-time Director.
- 146. The remuneration of a Managing Director or a Whole-time Director is (subject to the provisions of the Act and of these Articles and of any contract between him and the Company) shall from time to time be fixed by the Directors, and may be, by way of fixed salary, or commission on profits of the Company, or by participation in any such profits, or by any, or all of these modes.
- 147. (1) Subject to control, direction and supervision of the Board of Directors, the day-today management of the company will be in the hands of the Managing Director or Whole-time Director appointed in accordance with regulations of these Articles of Association with powers to the Directors to distribute such day-to-day management functions among such Directors and in any manner as may be directed by the Board.

Remuneration of Managing or Wholetime Director.

Powers and duties of Managing Director or Whole-time Director.

- (2) The Directors may from time to time entrust to and confer upon the Managing Director or Whole-time Director for the time being save as prohibited in the Act, such of the powers exercisable under these presents by the Directors as they may think fit, and may confer such objects and purposes, and upon such terms and conditions, and with such restrictions as they think expedient; and they may subject to the provisions of the Act and these Articles confer such powers, either collaterally with or to the exclusion of, and in substitution for, all or any of the powers of the Directors in that behalf, and may from time to time revoke, withdraw, alter or vary all or any such powers.
- (3) The Company's General Meeting may also from time to time appoint any Managing Director or Managing Directors or Wholetime Director or Wholetime Directors of the Company and may exercise all the powers referred to in these Articles.
- (4) The Managing Director shall be entitled to sub-delegate (with the sanction of the Directors where necessary) all or any of the powers, authorities and discretions for the time being vested in him in particular from time to time by the appointment of any attorney or attorneys for the management and transaction of the affairs of the Company in any specified locality in such manner as they may think fit.
- (5) Notwithstanding anything contained in these Articles, the Managing Director is expressly allowed generally to work for and contract with the Company and especially to do the work of Managing Director and also to do any work for the Company upon such terms and conditions and for such remuneration (subject to the provisions of the Act) as may from time to time be agreed between him and the Directors of the Company.

Chief Executive Officer, Manager, Company Secretary or Chief Financial Officer

Board to appoint 148. a) Chief Executive Officer/ Manager/ Company Secretary/ Chief Financial Officer

- Subject to the provisions of the Act,-
 - A chief executive officer, manager, company secretary or chief financial officer may be appointed by the Board for such term, at such remuneration and upon such conditions as it may thinks fit; and any chief executive officer, manager, company secretary or chief financial officer so appointed may be removed by means of a resolution of the Board;
 - ii) A director may be appointed as chief executive officer, manager, company secretary or chief financial officer.
- b) A provision of the Act or these regulations requiring or authorising a thing to be done by or to a director and chief executive officer, manager, company secretary or chief financial officer shall not be satisfied by its being done by or to the same person acting both as director and as, or in place of, chief executive officer, manager, company secretary or chief financial officer.

THE SEAL

- 149. The Board shall provide a Common Seal for the purposes of the (a) Company, and shall have power from time to time to destroy the use. same and substitute a new Seal in lieu thereof, and the Board shall provide for the safe custody of the Seal for the time being, and the Seal shall never be used except by the authority of the Board or a Committee of the Board previously given.
 - (b) The Company shall also be at liberty to have an Official Seal in accordance with of the Act, for use in any territory, district or place outside India.
- Deeds how 150. The seal of the company shall not be affixed to any instrument except executed. by the authority of a resolution of the Board or of a committee of the Board authorized by it in that behalf, and except in the presence of at least two directors and of the secretary or such other person as the Board may appoint for the purpose; and those two directors and the secretary or other person aforesaid shall sign every instrument to which the seal of the company is so affixed in their presence.

Dividend and Reserves

- 151. (1) Subject to the rights of persons, if any, entitled to shares with Division of profits. special rights as to dividends, all dividends shall be declared and paid according to the amounts paid or credited as paid on the shares in respect whereof the dividend is paid, but if and so long as nothing is paid upon any of the shares in the Company, dividends may be declared and paid according to the amounts of the shares.
 - (2) No amount paid or credited as paid on a share in advance of calls shall be treated for the purposes of this regulation as paid on the share.
 - (3) All dividends shall be apportioned and paid proportionately to the amounts paid or credited as paid on the shares during any portion or portions of the period in respect of which the dividend is paid; but if any share is issued on terms providing that it shall rank for dividend as from a particular date such share shall rank for dividend accordingly.
- 152. The Company in General Meeting may declare dividends, to be paid to members according to their respective rights and interests in the profits and may fix the time for payment and the Company shall comply with the provisions of Section 127 of the Act, but no dividends shall exceed the amount recommended by the Board of Directors, but the Company may declare a smaller dividend in general meeting.
- 153. a) The Board may, before recommending any dividend, set aside out of the profits of the company such sums as it thinks fit as a reserve or reserves which shall, at the discretion of the Board, be applicable for any purpose to which the profits of the company may be properly applied, including provision for meeting contingencies or for equalizing dividends; and pending such

The company in General Meeting may declare Dividends.

Transfer to reserves

The seal, its custody and

application, may, at the like discretion, either be employed in the business of the company or be invested in such investments (other than shares of the company) as the Board may, from time to time, thinks fit.

- b) The Board may also carry forward any profits which it may consider necessary not to divide, without setting them aside as a reserve.
- Interim Dividend. 154. Subject to the provisions of section 123, the Board may from time to time pay to the members such interim dividends as appear to it to be justified by the profits of the company.
- Debts may be deducted. 155. The Directors may retain any dividends on which the Company has a lien and may apply the same in or towards the satisfaction of the debts, liabilities or engagements in respect of which the lien exists.
- Capital paid up in 156. advance not to earn dividend. No amount paid or credited as paid on a share in advance of calls shall be treated for the purposes of this articles as paid on the share.
- Dividends in proportion to amount paid-up. 157. All dividends shall be apportioned and paid proportionately to the amounts paid or credited as paid on the shares during any portion or portions of the period in respect of which the dividend is paid but if any share is issued on terms providing that it shall rank for dividends as from a particular date such share shall rank for dividend accordingly.
- Retention of dividends until completion of transfer under Articles. 158. The Board of Directors may retain the dividend payable upon shares in respect of which any person under Articles has become entitled to be a member, or any person under that Article is entitled to transfer, until such person becomes a member, in respect of such shares or shall duly transfer the same.
- No Member to 159. No member shall be entitled to receive payment of any interest or dividend receive dividend or bonus in respect of his share or shares, whilst any money may be whilst indebted to due or owing from him to the Company in respect of such share or the company and shares (or otherwise however, either alone or jointly with any other person the Company's right of or persons) and the Board of Directors may deduct from the interest or reimbursement dividend payable to any member all such sums of money so due from thereof. him to the Company.
- Effect of transfer 160. A transfer of shares does not pass the right to any dividend declared thereon before the registration of the transfer.
- Dividend to joint 161. Any one of several persons who are registered as joint holders of any share may give effectual receipts for all dividends or bonus and payments on account of dividends in respect of such share.
- Dividends how 162. a) Any dividend, interest or other monies payable in cash in respect of shares may be paid by cheque or warrant sent through the post directed to the registered address of the holder or, in the case of joint holders, to the registered address of that one of the joint holders who is first named on the register of members, or to such person and to such address as the holder or joint holders may in writing direct.
 - b) Every such cheque or warrant shall be made payable to the order of the person to whom it is sent.

- Notice of 163. Notice of any dividend that may have been declared shall be given to dividend. the persons entitled to share therein in the manner mentioned in the Act.
- No interest on 164. No unclaimed dividend shall be forfeited and no unpaid dividend shall Dividends. bear interest as against the Company.

CAPITALIZATION

- 165. (1) The Company in General Meeting may, upon the recommendation Capitalization. of the Board, resolve:
 - (a) that it is desirable to capitalize any part of the amount for the time being standing to the credit of any of the Company's reserve accounts, or to the credit of the Profit and Loss account. or otherwise available for distribution: and
 - (b) that such sum be accordingly set free for distribution in the manner specified in clause (2) amongst the members who would have been entitled thereto, if distributed by way of dividend and in the same proportions.
 - (2) The sums aforesaid shall not be paid in cash but shall be applied subject to the provisions contained in clause (3) either in or towards:
 - (i) paying up any amounts for the time being unpaid on any shares held by such members respectively;
 - (ii) paying up in full, unissued shares of the Company to be allotted and distributed, credited as fully paid up, to and amongst such members in the proportions aforesaid; or
 - (iii) partly in the way specified in sub-clause (i) and partly in that specified in sub-clause (ii).
 - (3) A Securities Premium Account and Capital Redemption Reserve Account may, for the purposes of this regulation, only be applied in the paying up of unissued shares to be issued to members of the Company and fully paid bonus shares.
 - (4) The Board shall give effect to the resolution passed by the Company in pursuance of this regulation.
- 166. Whenever such a resolution as aforesaid shall have been passed, Fractional (1) the Board shall ----

Certificates.

- (a) make all appropriations and applications of the undivided profits resolved to be capitalized thereby and all allotments and issues of fully paid shares, if any, and
- (b) generally to do all acts and things required to give effect thereto.

- (2) The Board shall have full power -
 - to make such provision, by the issue of fractional certificates or by payment in cash or otherwise as it thinks fit, in case of shares becoming distributable in fractions; and also
 - (b) to authorise any person to enter, on behalf of all the members entitled thereto, into an agreement with the Company providing for the allotment to them respectively, credited as fully paid up, of any further shares to which they may be entitled upon such capitalization, or (as the case may require) for the payment by the Company on their behalf, by the application thereto of their respective proportions, of the profits resolved to be capitalized, of the amounts or any part of the amounts remaining unpaid on their existing shares.
- (3) Any agreement made under such authority shall be effective and binding on all such members.
- (4) That for the purpose of giving effect to any resolution, under the preceding paragraph of this Article, the Directors may give such directions as may be necessary and settle any questions or difficulties that may arise in regard to any issue including distribution of new equity shares and fractional certificates as they think fit.
- Inspection of Minutes Books of General Meetings. 167. (1) The books containing the minutes of the proceedings of any General Meetings of the Company shall be open to inspection of members without charge on such days and during such business hours as may consistently with the provisions of Section 119 of the Act be determined by the Company in General Meeting and the members will also be entitled to be furnished with copies thereof on payment of regulated charges.
 - Any member of the Company shall be entitled to be furnished within seven days after he has made a request in that behalf to the Company with a copy of any minutes referred to in sub-clause (1) hereof on payment of Rs. 10 per page or any part thereof.
- Accounts 168. a) The Board shall from time to time determine whether and to what extent and at what times and places and under what conditions or regulations, the accounts and books of the company, or any of them, shall be open to the inspection of members not being directors.
 - b) No member (not being a director) shall have any right of inspecting any account or book or document of the company except as conferred by law or authorised by the Board or by the company in general meeting.

FOREIGN REGISTER

Foreign Register. 169. The Company may exercise the powers conferred on it by the provisions of the Act with regard to the keeping of Foreign Register of its Members or Debenture holders, and the Board may, subject to the provisions of the Act, make and vary such regulations as it may think fit in regard to the keeping of any such Registers.

DOCUMENTS AND SERVICE OF NOTICES

- 170. Any document or notice to be served or given by the Company be signed by a Director or such person duly authorised by the Board for such purpose and the signature may be written or printed or lithographed.
- 171. Save as otherwise expressly provided in the Act, a document or proceeding requiring authentication by the company may be signed by a Director, the Manager, or Secretary or other Authorised Officer of the Company and need not be under the Common Seal of the Company.

Signing of documents & notices to be served or given. Authentication of documents and proceedings.

WINDING UP

- 172. Subject to the provisions of Chapter XX of the Act and rules made thereunder—
 - (i) If the company shall be wound up, the liquidator may, with the sanction of a special resolution of the company and any other sanction required by the Act, divide amongst the members, in specie or kind, the whole or any part of the assets of the company, whether they shall consist of property of the same kind or not.
 - (ii) For the purpose aforesaid, the liquidator may set such value as he deems fair upon any property to be divided as aforesaid and may determine how such division shall be carried out as between the members or different classes of members.
 - (iii) The liquidator may, with the like sanction, vest the whole or any part of such assets in trustees upon such trusts for the benefit of the contributories if he considers necessary, but so that no member shall be compelled to accept any shares or other securities whereon there is any liability.

INDEMNITY

- 173. Subject to provisions of the Act, every Director, or Officer or Servant of the Company or any person (whether an Officer of the Company or not) employed by the Company as Auditor, shall be indemnified by the Company against and it shall be the duty of the Directors to pay, out of the funds of the Company, all costs, charges, losses and damages which any such person may incur or become liable to, by reason of any contract entered into or act or thing done, concurred in or omitted to be done by him in any way in or about the execution or discharge of his duties or supposed duties (except such if any as he shall incur or sustain through or by his own wrongful act neglect or default) including expenses, and in particular and so as not to limit the generality of the foregoing provisions, against all liabilities incurred by him as such Director, Officer or Auditor or other officer of the Company in defending any proceedings whether civil or criminal in which judgment is given in his favor, or in which he is acquitted or in connection with any application under Section 463 of the Act on which relief is granted to him by the Court.
- 174. Subject to the provisions of the Act, no Director, Managing Director or other officer of the Company shall be liable for the acts, receipts, neglects or defaults of any other Directors or Officer, or for joining in any receipt

Directors' and others right to indemnity.

or other act for conformity, or for any loss or expense happening to the Company through insufficiency or deficiency of title to any property acquired by order of the Directors for or on behalf of the Company or for the insufficiency or deficiency of any security in or upon which any of the moneys of the Company shall be invested, or for any lossor damage arising from the bankruptcy, insolvency or tortuous act of any person, company or corporation, with whom any moneys, securities or effects shall be entrusted or deposited, or for any loss occasioned by any error of judgment or oversight on his part, or for any other loss or damage or misfortune whatever which shall happen in the execution of the duties of his office or in relation thereto, unless the same happens through his own dishonesty.

SECRECY

175. Every Director, Manager, Auditor, Treasurer, Trustee, Member of Secrecy (a) a Committee, Officer, Servant, Agent, Accountant or other person employed in the business of the company shall, if so required by the Directors, before entering upon his duties, sign a declaration pleading himself to observe strict secrecy respecting all transactions and affairs of the Company with the customers and the state of the accounts with individuals and in matters relating thereto, and shall by such declaration pledge himself not to reveal any of the matter which may come to his knowledge in the discharge of his duties except when required so to do by the Directors or by any meeting or by a Court of Law and except so far as may be necessary in order to comply with any of the provisions in these presents contained.

(b) No member or other person (other than a Director) shall be entitled to enter the property of the Company or to inspect or examine information etc. the Company's premises or properties or the books of accounts of the Company without the permission of the Board of Directors of the Company for the time being or to require discovery of or any information in respect of any detail of the Company's trading or any matter which is or may be in the nature of trade secret, mystery of trade or secret process or of any matter whatsoever which may relate to the conduct of the business of the Company and which in the opinion of the Board it will be inexpedient in the interest of the Company to disclose or to communicate.
